Strategy & Vision

Develop the Strategic intent and prepare the Strategic Plan

Clear & concise purpose of the Association

Terms of Reference

That the Council clearly define and articulate (simply) our identity, purpose and vision

Link a member of the Council to an area of the ministry region; e.g. social justice, spiritual direction

The Council to discern their priority:

- o Governance;
- o "spiritual family"

Ensure more diverse Council; e.g. women, not only Principals / Aps, beyond schools

Building the relationship between the Association's Council and local groups

To ensure the voice of the Association is embedded in the new MYM programme

More regular visits from Marist reps. Assisting growth

Bridge the Gap

- o Links between schools & organisations
- Clear ways to connect & stay part of the spiritual family

A clearer vision and purpose

Emphasise the diversity of a spiritual family

"Bridge the gap" between a Marist community & the next

 (e.g. student may not reconnect with the Marist family until they send their own child to a Marist school)

Clear links between each region

 (e.g. if a student moves interstate to study there should be a person to refer them to). Make and "ex-students" page

To clarify the role of the Council & Association

Connecting / linking local & regional groups to the Council – a member to link with

Local life / groups / personal engagement

That the Council support groups with resourcing & animation

Establish clear mechanism for evaluating project proposals

Support / Mentoring for local leaders, new members and those associated with Marist Ministries (Spiritual Director)

Get Local Coordinators together to discuss, exchange ideas, get resources

Acknowledge, support and resource ministries, beyond the "big 4" recognized ministries

Utilise the skills of members to support, mentor & represent various initiatives of Marist works

To activate belonging in a virtual network

To encourage belonging to a local group that is not ministry defined

Continue with Resources used at a local level

Investigate opportunities for members to interact via social media

Structure groups according to needs / interests not geographical location

Recognise & support our efforts of mission at local levels

Help us go to the margins in our own context

Community & communication which connects local groups

Strengthen the national & regional networking

Continue to provide resources people to develop our identity as Adelaide Marist

Resourcing & accompaniment of local groups & succession of this

Invite people to contribute a \$ 'levy'

Promote & encourage groups of "like-minded" people to gather to "be' or 'act' (outside local groups)

Create resources to promote 'Association' for young people in schools to continue their Marist journey

To suggest 'structure' (with flexibility) of the local Association groups

There is a greater emphasis on involving (inviting) members who aren't directly involved in Marist ministries

With guiding principles from the Council, local groups should be able to determine their ministry based on the needs of their community
